Scott Emergency Communications Center Board will receive single prime sealed bids for the Back-Up 911 Center Renovations project until 2:00 pm local time on March 15, 2012 at the Scott County Purchasing Department, Sixth Floor, 600 West Fourth Street, Davenport, Iowa 52801 at which time and place all bids will be publicly opened and read aloud.

This project includes: Interior demolition and renovations of 911 call takers area including finishes of paint, carpet, and ceiling tile and grid replacement. Additionally, existing mechanical and electrical systems will be modified as required, along with the installation of a new supplemental cooling and emergency power generator, and UPS equipment.

The copies will be available about February 17, 2012. A deposit in the amount of \$25.00 for each set ordered is required. The following information must accompany the deposit: Company name, mailing address, street address, phone and facsimile numbers and type of bidder (i.e. General, Mechanical or Electrical Subcontractor to General, or other). A refund of \$25.00 will be sent for each set (including addenda) returned to ARC in good condition within ten (10) calendar days of the award date, subject to the conditions of AIA Document A701. Refunds will not be given if the plans are returned to the Architect's Office.

Make proposals on the bid forms supplied in the Project Manual. No oral, telegraphic or telephonic proposals or modifications will be considered. Submit with each bid, a certified check or acceptable bidder's bond payable to Scott County in an amount equal to ten percent (10%) of the total bid. The successful bidder will be required to furnish satisfactory Labor and Material Payment Bond, and Performance Bond.

Bids may not be withdrawn within forty-five (45) days after the scheduled time of opening bids, without the consent of the Owner. The Owner reserves the right to accept any bid or to reject any or all bids, or parts of such bids, and waive informalities or irregularities in bidding.

The Owner intends to award this contract on or about March 29, 2012 and requires Substantial Completion of the project on or before July 31, 2012.

A pre-bid examination of the project site will be conducted on Tuesday, March 6, 2012 at 9:00 a.m.
