Bids will be considered by the owner at a public meeting to be held at Scott County Conservation Board, 14910-11th Avenue, Davenport, IA 52804, 03:00 PM , local time, April 19, 2023 or at such later time and place as may then be fixed.

The extent of work on this project is the furnishing of all labor, equipment, and materials for the construction of improvements generally described as follows:

Inspection of approximately 3,397 linear feet of sewer laterals, refurbishment of approximately 1,360 linear feet of sewer main, and refurbishment of 4 manholes, including lateral connections. Depending on results of the field inspection, the project may also include point repair of sewer laterals, minor manhole adjustments, service riser repairs, and new manhole castings.
