- 4.01 Bidder agrees that the Work will be substantially complete and will be completed and ready for final payment in accordance with Paragraph 15.06 of the General Conditions on or before the dates or within the number of calendar days indicated in the Agreement.
- 4.02 Bidder agrees that the Work will be substantially complete on or before **June 28, 2024**, and will be completed and ready for final payment in accordance with Paragraph 15.06 of the General Conditions on or before **July 31, 2024**.
