The extent of work on this project is the furnishing of all labor, equipment, and materials for the construction of improvements generally described as follows:

Scott County Park - This project includes construction of an 8-foot wide PCC trail, 2 HMA parking lots, earthwork, a 10' x 8' box culvert, storm sewer, erosion control, pavement markings, signage and traffic control. West Lake Park - This project includes construction of an 8-foot wide PCC trail, a small HMA parking lot, earthwork, and concrete stairs and handrail. Also includes erosion control, pavement markings, signage and traffic control.

All work is to be done in compliance with the drawings and specifications prepared by Shive-Hattery, Inc., which are now on file for public examination at Shive-Hattery's Office 2144 56th Avenue West, Bettendorf, IA 52722 and at Scott County website:
