Sealed bids will be received by the Owner at the Scott County Conservation Board, 14910-110th Avenue, Davenport, IA 52804 until 03:00 PM, local time, on October 11, 2023. At that time and place, sealed bids will be opened and publicly read aloud for the West Lake Park - Summit Campground Sanitary Sewer.

Bids will be considered by the owner at a public meeting to be held at Scott County Conservation Board meeting, location to be published on the Scott County Conservation Board website, 03:00 PM, local time, October 18, 2023 or at such later time and place as may then be fixed.

The extent of work on this project is the furnishing of all labor, equipment, and materials for the construction of improvements generally described as follows:
Installation of approximately 5,000 linear feet of 6-inch gravity sewer, including manholes and service to each RV campsite.

All work is to be done in compliance with the drawings and specifications prepared by Shive-Hattery, Inc., which are now on file for public examination at Shive-Hattery's Office 2144 56th Avenue West, Bettendorf, IA 52722.
