SUBJ: Approval of Appropriations and Authorized Positions for FY25

Please find attached a listing of appropriations and authorized positions recommended for FY25. There are no appropriation changes from the April 25, 2024 budget adoption amount of \$136,690,626 (including the golf course and MEDIC EMS enterprise funds).

The recommended authorized position levels for next year are presented in a format which provides an accurate tracking method for changes in authorized position levels as approved by the Board throughout the fiscal year as well as at budget time. The first column lists the authorized position levels as of the end of the third quarter of the current fiscal year as previously submitted to Board of Supervisors in the latest Quarterly Financial Summary Report. The next column shows the fourth quarter changes approved during the current fiscal year through 6, 2024. The third column shows the budget changes as included in the resolution approved by the Board for FY25.

Finally, these three columns added (or subtracted) together total the final column listed as the recommended FY25 authorized FTE level of 688.96 FTE's. There were a number of personnel changes included with the FY25 budget. Facilities and Support Services added 1.0 FTE Senior Maintenance Workers, and 2.0 FTE Custodian. Information Technology added 1.0 Senior Office Assistant. The Youth Justice and Rehabilitation Center added an Administrative Assistant, 1.0 FTE and 5.0 FTE Detention Youth Counselors. There were a number of classification reclassification approved as well.

This authorized position level information is provided jointly by both the Human Resources Department and Administration. It is recommended that the Board approves the attached appropriations and authorized positions for FY25 at your next Board meeting.

APPROVAL OF APPROPRIATIONS AND AUTHORIZED POSITIONS FOR FY25

BE IT RESOLVED by the Scott County Board of Supervisors as follows:

Section 1. Appropriations and authorized positions for the FY25 budget adopted April 25, 2024 are hereby approved in the amount of \$136,690,626 and 688.96 FTE's as presented by the County Administrator.

Section 2. The County Administrator is hereby directed to establish appropriations totaling \$136,690,626 as found in the summary schedules in the Office of the County Auditor and the Office of the County Administrator.

Section 3. This resolution shall take effect immediately.
