

***March 10, 2011 Minutes of the Scott County Conference Board***

- The Scott County Conference Board met this 10th day of March in the Room 638 of the Scott County Administrative Center, 600 W. 4<sup>th</sup> St., Davenport, Iowa. The meeting was called for the purpose of approving and adopting the combined budget for the County Assessor's Office for the 7/1/2011 to 6/30/2012 fiscal year, and to act upon any other necessary business that may come before the Board.
- The meeting was called to order by Tom Sunderbruch, Chair of the Supervisors, at 4:30 p.m., with the following members present:

- A legal quorum was established by all voting units. Voting heads were appointed:

- A motion to accept, as presented, the minutes of the February 10, 2011 meeting was made by Freemire and seconded by Dierickx. The motion passed unanimously.
- The Assessor presented the Proof of Publication Notice for the 2011-2012 FY Budget published in the Quad City Times, February 20, 2011.

- The Assessor gave a brief overview of the budget including 2.5% salary increase with no increase in the health costs.
- On a motion by Freemire and a second by Dierickx the Public Hearing on the 2011-2012 FY Budget was opened at 4:40 p.m. by Chair Sunderbruch. Assessor Denklaus reported on one phone inquiry about the budget. Mr. McGreevy and Board members asked the Assessor about the amounts of changes, assessment mailing procedures, and the IPERS increase. The Assessor explained that all of the rural properties were changed based on the new Iowa Manual and door to door review. Property owners were all notified by mail and informal hearings were being scheduled. The Public hearing was closed at 4:53 p.m. on a motion by Freemire and a second by Dierickx. The motion carried unanimously.
- The Board on a motion by Freemire and a second by Dierickx then voted on the 2011-2012 Combined Budget as presented. A roll call vote was taken with all members present voting yes.
- No old business.
- No new business.

The meeting was adjourned at 4:55 p.m. on a motion by Dierickx and a second by Cusack. All units voting yes.
