

Scott County Board of Supervisors
September 11, 2025 5:00 p.m.

The Board of Supervisors met pursuant to adjournment with Maxwell, Paustian, Beck, Bribresco and Dickson present. The Board recited the Pledge of Allegiance.

Moved by Dickson, seconded by Beck a motion approving the minutes of the August 26, 2025 Committee of the Whole, the August 28, 2025 Board Meeting and the September 4, 2025 Special Board Meeting. All Ayes.

Moved by Dickson, seconded by Beck that the following thirteen consent agenda items be approved. All Ayes.

BE IT RESOLVED: 1) That the Fleet Manager has the authority to purchase two (2) new MY27 Ford E450 chassis with the remounting of existing Life Line boxes which includes new power load systems and cots for MEDIC EMS of Scott County from Klockes Emergency Vehicles, Sterling, IL, in the amount of \$227,081.00 each for a total of \$454,162.00. 2) Assets being replaced are #5794 and #5801. 3) This resolution shall take effect immediately.
