Supervisor Bribriesco reviewed that she believes this promotes urban sprawl.

BE IT RESOLVED: 1) As the local governing body responsible for the approval of subdivision plats within its rural jurisdiction, the Scott County Board of Supervisors has on this 9th day of October 2025, considered the final plat of Baltic Property. Said plat is a subdivision in Part of the SE ½ of the NE ½ of Section 1 of Buffalo Township in Scott County, Iowa, and having found the same made in substantial accordance with the provisions of Chapter 354, Code of Iowa, and the Scott County Subdivision Ordinance, does hereby approve the final plat of said subdivision. 2) The Board Chairman is authorized to sign the Certificate of Approval on behalf of the Board of Supervisors and the County Auditor to attest to his signature. 3) This resolution shall take effect immediately.

County Administrator Mahesh Sharma spoke on a Department Head meeting, including the United Way campaign and an upcoming Hunger Drive for Riverbend Food Bank. He also reviewed the space study presentation from Tuesday and will start bringing items to the Board. He reviewed an Artificial Intelligence focus group, the Humane Society contract is still in progress, and an Intergovernmental meeting with Davenport, Bettendorf and Bi-State. He also reviewed working towards the completion of the YJRC facility. He also reviewed the upcoming ISAC 99 county tour, a joint meeting with the Board of Health, and a Strategic Plan review at the next Committee of the Whole.

Supervisor Beck spoke on a Waste Commission meeting with two items of interest: a new cell construction contract and cleaning of the methane gas from the landfill. He reviewed a meeting of the Ports of Eastern Iowa with an upcoming 2026 National Waterway Conference and attended RDA grant presentations.

Supervisor Dickson spoke on the Operations Committee for Workforce Development.

Supervisor Paustian spoke on an appearance on Channel six news.

Supervisor Bribriesco spoke on the annual Roadside Conference including information presented on native prairies.

Supervisor Maxwell provided an update on the Roadside Conference and the Planning and Zoning meeting, including information regarding the proposed power plant.

Moved by Paustian, seconded by Bribriesco at 5:35 p.m. a motion to adjourn. All Ayes.
