## CHAPTER 11 RESTRICTION ON PARKING OF TRUCKS ON COUNTY STREETS IN RESIDENTIAL SUBDIVISIONS

### SEC. 11-1. PURPOSE

The purpose of this ordinance is to restrict and prohibit the parking of certain type trucks on county public streets in residential subdivisions. This restriction is necessary to ensure the safety of traffic, prevent damage to the public streets and facilitate snow removal operations.

### SEC. 11-2. GENERAL JURISDICTION

The rules of this chapter shall apply to only those areas specified. All the rules and regulations and definitions outlined in the 1989 <u>Code of Iowa</u>, Chapter 321 and more specifically Section 239 shall apply.

### SEC. 11-3. DEFINITIONS

For purposes of this chapter, certain terms and words are hereby defined.

- 1. <u>County Public Roads or Streets:</u> Any street that has been officially taken into the Scott County road and street system by resolution of the Board, is included in the list of Scott County roads and streets submitted to the Iowa Department of Transportation by the County Engineer and is maintained by the Scott County Secondary Roads Department.
- 2. <u>Residential Subdivision:</u> Any subdivision that was developed for residential purposes and whose primary function is to provide for the construction and accommodation of single family, multi-unit or apartment type dwelling units.
- 3. <u>Trucks:</u> Any motor truck, truck-tractor, trailer or semi-trailer with a licensed weight in excess of five (5) tons.
- 4. <u>Person:</u> Every natural person, firm, co-partnership, association or corporation.
- 5. Owner: A person who holds the legal title of a vehicle, or in the event a vehicle is the subject of a security agreement with an immediate right of possession vested in the debtor, then such debtor shall be deemed the owner for the purpose of this chapter.

# CHAPTER 11 RESTRICTION ON PARKING OF TRUCKS ON COUNTY STREETS IN RESIDENTIAL SUBDIVISIONS

### SEC. 11-4. TRUCKS AND TRAILERS - PARKING RESTRICTIONS

No person shall park any truck as herein defined on any Scott County public road or county public street in a residential subdivision, except while actively loading or unloading.

### SEC. 11-5. ENFORCEMENT AND PENALTY

Any person in violation of this ordinance shall be guilty of a misdemeanor and shall, upon conviction, be fined not to exceed Twenty-Five Dollars (\$25.00), or be imprisoned not to exceed seven days in the County jail.
