PRESIDENT TRUMP SIGNS BLUE WATER NAVY ACT

On June 25th, 2019, President Trump signed the Blue Water Navy Vietnam Veterans Act of 2019 in to law. This legislation extends disability benefits for medical conditions related to Agent Orange exposure to those veterans that served aboard ships that were off the coast of Vietnam.

H.R. 299 also includes the provision that all veterans who were exposed to Agent Orange should receive the same presumptive benefits. It states, "A veteran who, during active military, naval, or air service, served offshore of the Republic of Vietnam during the period beginning on January 9, 1962, and ending on May 7, 1975," will be eligible for disability compensation for presumptive conditions of herbicide exposure.
