Scheduling of Joint Meeting with Supervisors:

The Board agreed to schedule the joint meeting with the Scott County Supervisors at 5:00 p.m. on November 9th after our regular board meets from 3:00 to 4:30.

Approval of 2005 Scott County Controlled Deer Hunt Application, Rules & Regulations:

Marc Miller said one change is to have 100 licenses available so everyone would have a chance to get a second deer if desired. The unused licenses would then be available to be used by youth or hunters needing assistance. This year there will be 12 licenses available at the Wapsi center for the State's first shotgun season only.

MOTION: A motion was made by Mr. Mohr to approve the 2005 Scott County Controlled Deer Hunt application, Rules & Regulations as presented, seconded by Mr. O'Donnell, and passed.

Golf Update:

Mr. Kean gave the golf update for July.

Visioning Survey Update:

Sam Lankford from the University of Northern Iowa talked about sending out the survey. He said that they would send one to our data base of campers and shelter users and one to a data base of county residents. The usual response rate is 50% to 60%. They will also send a mailing to staff and will send out students to interview past and current staff. They want to find out how the Conservation Board can grow and develop and how do they support this growth. When they get the results of the surveys and interviews, they will present it at a Board Meeting and then present it at the IACCB Conference next year.

Lake Odetta Update

Mr. Kean said the Road Department will complete their work by the end of this week. He may call the Board members if work is to start on the dams before the next meeting. He estimates the cost to be \$50,000 but we have a \$30,000 grant.

Pool and Beach Closing

The press release that went out to the media on August 8^{th} stated that the facilities would be open August 15-19 from 4 p.m. -8 p.m. and will be closed during the day. Starting August 20, they will be open on weekends only through September 5, Labor Day weekend, after which, the pool and beach will close for the season. The paddle boats and concessions will remain open weekends only through September 18 and then close for the season.
