A joint ribbon cutting ceremony with the Board of Supervisors is scheduled for May 23<sup>rd</sup> at 2 p.m. to celebrate opening the pool with the new waterslide.

## Discussion of Splash Pad Proposals:

Water Odyssey submitted a proposal showing their suggestions for the Splash Pad's features. A proposal from Vertex has not been received. Water Odyssey's plan was reviewed and discussed.

#### **MOTION:**

A motion was made by Ms. Fennelly to approve Water Odyssey's suggestions for the Splash Pad's features and placement with the ability to review and make changes as the process continues, seconded by Mr. Weis, all in favor and passed. Mr. Kean will be contacting Burbach Aquatics so they can begin the design specs for the project.
