#### **BUSINESS:**

#### Review of North Scott High School Special Event Application:

The application was reviewed and discussed by the Board members.

#### **MOTION:**

A motion was made by Mr. Weis to approve the North Scott High School Cross County Meet on September 16, 2008, at Scott County Park subject to the conditions as discussed with Conservation staff. Also, the Board directed that fees for the event will be negotiated based on the number of Conservation staff required to be present. In addition, the Board agreed that North Scott High School could sell their own concessions at the event, seconded by Ms. Fennelly, all in favor and passed.

## Review of 5<sup>th</sup> Annual Youth Fishing Derby Special Event Application:

The application was reviewed and discussed by the Board members.

#### **MOTION:**

A motion was made by Ms. McAleer to approve the date of September 13, 2008, to use West Lake Park for their 5<sup>th</sup> Annual Fishing Derby. The Board has directed that no fees be charged as it is a charitable event, seconded by Mr. Weis, all in favor and passed.

## Review of Movie Production Filming at Pioneer Village Special Event Application:

The application was reviewed and discussed by the Board members.

#### **MOTION:**

A motion was made by Ms. McAleer to formally approve the production group to film portions of the movie, Children of the Corn, at Pioneer Village subject to the conditions as discussed with Conservation staff and as stated on the application form. The Board has directed that fees of \$3,000 be charged.

## Approval of Resolution for Allen's Grove Park Hours and Improvements:

This year's floods silted in the boat ramp at Allen's Grove and even after efforts to remove the debris, the ramp was still unusable. Staff is requesting the Board to approve the re-location of the boat ramp and the improvements as shown in the Plan drawn up by Verbeke-Meyer Consulting Engineers, P.C. In addition, staff is requesting that the Board establish park hours at Allen's Grove as detailed on the drafted Resolution given to the Board members.

A motion was made by Ms. Fennelly to approve the re-location of the boat ramp and improvements at Allen's Grove Park as presented, in addition, to approve as drafted the Resolution Approving Park Hours at Allen's Grove Park & Public Hunting Area, seconded by Ms. McAleer, all in favor and passed.

This position is a seasonal position (1040 hr/year) includes housing but is not benefit eligible. An advertisement has been placed in the Quad-City Times to find a replacement.

#### Splash Pad Update:

This is a little behind schedule, but work should start sometime late September.

#### Plant Some Shade:

This is scheduled for 10/02/08, the trees available are: Swamp White Oak; Red Oak; Sugar Maple; Adams Flowering Crabapple; and Norway Spruce.
