## 2008 Controlled Deer Hunt Final Report / 2009 Post-Hunt and Pre-Fawn Aerial Survey:

The deer report was reviewed and discussed. The Board commended Scott County Park Manager, Dave Ong, for his work putting the report together.

#### Projects Update:

- Due to weather conditions no additional work can be done on the Scott County pool's new spray pad addition. Most of the piping work is done - just waiting for better weather conditions.
- Construction is underway at Pioneer Village's new jail building.
- Work is progressing on the Summitt restroom renovation.

#### Golf Course Discussion:

John Valliere, Glynns Creek Golf Course Pro, presented information to the Board concerning 2008 liquor sales.

John Valliere also presented a proposal to the Board requesting the addition of season passes/memberships being made available at the golf course. The Board discussed the options and fee structures of the proposal.
