Acceptance of NRPA "Take Me Fishing" Grant Award

The Scott County Conservation Board was selected as a grant recipient of the 2010-2011 Take Me Fishing program through the efforts of Dave Murcia, Naturalist/Director of the Wapsi River Environmental Education Center. This is the third year the Conservation Board has been awarded this grant.

MOTION:

A motion was made by Mr. O'Donnell to accept the 2010-2011 Take Me Fishing grant in the amount of \$4,000, seconded by Mr. Weis, all in favor and passed.

Approval of Trespass Notification Form:

After reviewing Conservation Department's procedure for banning disruptive persons from our parks a new Trespass Notification form was developed to formalize the course of action. This new process will help the Park Rangers deal with situations better before they become unmanageable.

MOTION:

A motion was made by Mr. O'Donnell to adopt using the Trespass Notification form to enforce park rules and regulations, seconded by Ms. Fennelly, all in favor and passed.

Approval of Special Event Application for Governor's Run race at Scott County Park:

This race is an annual event and staff recommends approval.

MOTION:

A motion was made by Ms. McAleer to approve the application for the Governor's Run race on July 17th & 18th at Scott County Park subject to the conditions as discussed with Conservation staff and as stated on the Permit Form along with Special Event fees of \$405, seconded by Mr. Weis , all in favor and passed.

Approval of Special Event Application for Walk With Travis at Scott County Park
This will be the first time for this event and staff recommends approval.

MOTION:

A motion was made by Mr. Weis to approve the Special Event Application for the Walk With Travis on September 18th at Scott County Park, subject to the conditions discussed with Conservation staff and on the Permit Form with no fees being charged, seconded by Ms. Fennelly, all in favor and passed.
