MINUTES: The minutes of the December 8, 2010 meeting were reviewed for additions and/or corrections.

MOTION: A motion was made by Ms. McAleer to approve the minutes from the December meeting as presented, seconded by Mr. Weis, all in favor and passed.

BILLS: Reviewed for the month of December in addition to the corrected November report.

MOTION: A motion was made by Mr. Weis to approve the bills from December and also the corrected November report as presented, seconded by Ms. McAleer, all in favor and passed.

BUSINESS:

Election of Officers:

Currently the officers are Rich Mohr, Chairman; John (Skip) O'Donnell, Vice Chairman; and Carol Fennelly, Secretary.

MOTION:

A motion was made by Ms. McAleer to continue with the current slate of officers for 2011, seconded by Mr. Weis, all in favor and passed.

Approval of Seasonal Pay Rates:

Staff recommended a 25¢ increase for each pay grade as seasonal salaries were not increased last year and we feel we will be able to stay within budget limits.

MOTION:

A motion was made by Ms. McAleer to approve the 25¢ increase to each seasonal salary pay grade, seconded by Mr. Weis, all in favor and passed.

Approval of John Deere mower bids for the parks:

Staff recommended approval of the purchase (GSA pricing) of the mowers with the assurance that we will stay within our equipment budget line item and if necessary, not purchase all of the mowers.

MOTION:

A motion was made by Mr. Weis to approve the purchase of the John Deere mowers with the condition of staying within budget allocation, seconded by Ms. McAleer, all in favor and passed.

Discussion of the Concealed Weapons Law Change:

Mr. Kean described the new law which became effective January 1, 2011. At this time he has not received a final clarification regarding if Conservation parks fall under the State Legislature weapon free zones or Scott County policies prohibiting bringing a concealed weapon on any County property. This will be discussed again when we receive an official clarification of the law.
