#### **MOTION:**

The Board reviewed the letter from Al Dufour requesting to conduct a series of surveys at Buffalo Shores beach between June 16<sup>th</sup> – August 7<sup>th</sup>.

#### Approval of 2010 Final Deer Report & Recommendations:

The deer report was reviewed and discussed. The Board commended Scott County Park Manager, Dave Ong, for his work putting the report together.

#### **MOTION:**

A motion was made by Ms. Fennelly to approve the 2010 Scott County Conservation Board Controlled Deer Hunt Report and the 2011 Post-Hunt and Pre-Fawn Aerial Survey plus the 2011 Recommendations allowing 50 hunters at Scott County Park and a "mentored" hunt of 4 archery tags at the Wapsi Center, seconded by Mr. O'Donnell, all in favor and passed.

#### Lake Canyada Update:

The Board discussed the memo from I & R Properties that was received on the date of the Board meeting. Mr. Kean expressed that we are not getting enough detailed information from I & R Properties regarding data from the flow meters that were recently installed. Mr. Kean will continue to monitor this situation.

## Discussion of Scott County Sustainability Plan:

The Board reviewed and discussed the Sustainability Plan and how Conservation will be involved in the overall plan.

## Information regarding second budget amendment for FY10-11:

Mr. Kean reported that Conservation will have an increase in equipment costs but this will be covered by an offsetting increase in revenue due higher prices from the sale of the replaced equipment. Also there will be an increase due to unbudgeted hardware replacement needed for network/pc upgrades and software enhancements associated with Citrix and Rec Trac, and the need to address poor overall department network performance. This amount will either be covered by the IT Department or from an actual general fund increase, or Conservation's Equipment Reserve.

#### **MOTION:**

A motion was made by Mr. Weis to approve the Second Budget Amendment for FY10-11, seconded by Ms. Fennelly, all in favor and passed.

## Information regarding faunal study at Scott County Park:

A request was received from Karen Kinkead, Wildlife Diversity Program Coordinator at the Iowa Department of Natural Resources to include Scott County Park in their Multiple Species Inventory and Monitoring Program this year. Data will be collected through October 31<sup>st</sup> and we will receive a report of the results of their study.

A motion was made by Mr. O'Donnell to approve the Faunal Study at SCP conducted by the Iowa Dept of Natural Resources, seconded by Mr. Weis, all in favor and passed.
