BUSINESS:

Lake Canyada Update:

The Board was shown the Lake Canyada Sanitary Sewer Flows spreadsheet submitted by I & R Properties. It was felt that the flows for the Lake Canyada South Side were inaccurate as they showed extremely low up until May 21st. A third party company was called to verify the accuracy of both Lake Canyada and Conservation's flow meters. Since the verification, Lake Canyada's south side flow meter has been reading more accurately starting May 22nd. We continue to work with I & R Properties and have met with their manager from Ohio at our office and reviewed the Lake Canyada meter calibration together.

The monthly reports were reviewed by the Board. Bad weather conditions in May affected revenue for the month.

Tour of Buffalo Shores:

Problems have been: overcrowding, completely full parking lots, underage drinking, dealing with over-drinking, garbage, and shortage of personnel to cover both Buffalo Shores and West Lake Park campgrounds. Roger Larson, Park Manager of BSP and WLP was there to answer questions and discuss the situation. At this time, this was informational for the Board and when/if necessary possible solutions will be discussed at further board meetings.
