## Approval of Golf Cart Bid for Glynns Creek Golf Course:

The Board reviewed the Bid Sheet for the golf cart bids. The Board was also informed that the 2012 golf carts purchase price from QC Golf Cars were for carts that did not meet specifications. Staff recommended the low total bid from Harris Yamaha Golf Cars. An item that was overlooked in the bid request was for hubcaps for all of the carts. Harris Yamaha stated that they would be an additional \$18 per vehicle.

### **MOTION:**

A motion was made by Ms. Fennelly to approve the 2012 Golf Cart Purchase Bid along with Alt #1 Purchase and Alt #2 Purchase in the amount of \$187,750 from Harris Yamaha Golf Carts, and additionally approve the purchase of hubcaps for the 79 carts totaling \$1,422, seconded by Mr. O'Donnell, all in favor and passed.

## Approval of FY13 Budget and Capital Projects:

The Board reviewed the proposed FY13 Capital Projects and FY13 Budget.

## Lost Grove Lake Update:

The Board discussed Conservation's involvement, if any, and still need to understand from the DNR where the money would come from if campgrounds/cabins/trails are to be developed. Mr. Kean informed that Board that the DNR wants to hire a consultant/planner to develop a plan with the DNR's forestry, fish and wildlife divisions; Scott County Planning & Zoning, Conservation and County Administrator Dee Bruemmer. A tour of Lost Grove Lake conducted by the DNR will be arranged for both the Board of Supervisors and the Conservation Board.
