**MINUTES:** The minutes of the December 14, 2011 meeting were reviewed for additions and/or corrections.

**MOTION:**

A motion was made by Ms. Fennelly to approve the minutes from the December meeting as presented, seconded by Mr. Weis, all in favor and passed.

**BILLS:** Reviewed for the month of December.

**MOTION:**

A motion was made by Ms. Fennelly to approve the bills from December as presented, seconded by Ms. McAleer, all in favor and passed.

**CORRESPONDENCE/INFORMATION:**

**BUSINESS:**

***Election of Officers:***

**MOTION:**

***Approval of Seasonal Pay Rates:***

***Approval of GPS System Quotes for Glynns Creek Golf Course:***

The below proposals were reviewed and discussed for the golf carts GPS systems with staff recommending the quote from To The Green.
