MINUTES: The minutes of the January 12, 2012 meeting were reviewed for additions and/or corrections.

MOTION:

A motion was made by Ms. Fennelly to approve the minutes from the January meeting as presented, seconded by Mr. Weis, all in favor and passed.

BUSINESS:

Review of County Administration Budget Presentation:

This was informational for the Board. The FY13 Budget adoption by the Board of Supervisors is scheduled for Thursday, March 1st.

Approval of Removal of Shelter Usage Restriction:

It has been a long standing practice to not allow weddings or receptions in the park's shelters. This is something that we have been requested by the public to reconsider. The Board discussed this and staff recommended that we now allow weddings and receptions but the requestor will need to complete a Special Event application, have Park Manager approval and be subject to a damage deposit. These Special Event applications will only need Park Manager approval and will not require Board approval.

MOTION:

A motion was made by Mr. Weis to approve removing the restriction of not allowing weddings or receptions in the park's shelters, having the requestor complete a Special Event Application only needing approval from the Park Manager, seconded by Ms. McAleer, all in favor and passed.

Approval of Special Event Application from People & Pooches Dog Walk at SCP: After review and discussion, staff recommended approval of this event charging \$105 for the shelter rental.

MOTION:

A motion was made by Ms. Fennelly to approve the Special Event Application for a People & Pooches Dog Walk at Scott County Park on May 5, 2012, seconded by Ms. McAleer, all in favor and passed.

Approval of Special Event Application from Iron Lion Disc Golf for a tournament at WLP:

After review and discussion, staff recommended approval of this event charging \$95 in fees.

This is an annual request from North Scott High School and staff recommends approval.

Lake Canyada Update:

Mr. Kean informed the Board that I&R Properties are now behind four monthly payments of \$3,000/month. They have been informed of this and have stated they will look into the matter. Their attorney wants an agreement to a long term schedule of activities. Before discussing this with them we want verification of the cut back on infiltration and an assurance that they stay current with their payments. As of now the flows at the treatment plant have been steady with no spikes but we also have not had much rain so there has not been enough time/weather to feel completely comfortable with the readings.
