# Approval of Special Event Application from North Scott Jr. High School for cross country meet at Scott County Park:

Staff recommended approval charging fees of \$400 with any additional costs to be assessed after the event.

# Approval of Special Event Application from GMRAS Adventure Race at Scott County Park:

This is a new event and only a portion of the race will involve Scott County Park. Staff recommended approval charging fees of \$90 for shelter and administrative fees.

## **MOTION:**

A motion was made by Ms. Fennelly to approve the use of Scott County Park for the Great Mississippi River Adventure Series (GMRAS) race on 6/30/12, charging the above recommended fees, seconded by Ms. McAleer, all in favor and passed.

## Approval of Special Event Application from WMT Radio Tractorcade:

This is a new event and only a portion of the event will involve Scott County Park. Staff recommended approval charging fees of \$95 for shelter and administrative fees.

Mr. Kean thought that there should be a hearing before a Judge in May and expressed that our goal is not to solve their infiltration problem but to have them get it resolved so they can get off of our waste treatment system.

## Lost Grove Lake Update:

Mr. Kean, Dee Bruemmer, and DNR staff met on Monday the 19<sup>th</sup> to review Lost Grove Lake. The DNR staff will be looking at different options for public use.
