## Approval of Special Event Application from Special Olympics/Polar Plunge:

The Board reviewed the application requesting to use West Lake Park Beach for their annual Polar Plunge on October 27<sup>th</sup>. Staff recommends approval with no fees charged as it is a charitable event and only needs minimal staff involvement.

## Scott Park Road Boat Ramp Discussion:

The DNR has asked the Conservation Department to manage a new boat ramp they are constructing north of Fairyland. Mr. Kean asked the Board if they would support a management agreement to maintain the boat ramp and if so, when the agreement is formalized he will present it to the Board for their review.

#### **MOTION:**

A motion was made by Ms. McAleer to approve negotiating a management agreement with the DNR to maintain the new boat ramp located north of Fairyland once it is completed, seconded by Ms. Fennelly, all in favor and passed.

## ADA Assessment Update:

The management team for Recreation Accessibility Consultants (RAC) have completed their assessments of all of the park sites. The final report should be finished by the end of February 2013 and RAC will also provide employee training so we are more aware of legal requirements for future projects.

## Update on Applications for Scott County Park Controlled Deer Hunt:
