## BUSINESS:

## Review of ADA Assessments:

There is a large amount of information to review and understand that was received from Recreation Accessibility Consultants regarding the access audit of our sites and facilities. Mr. Kean explained that we will need to prioritize the recommendations and the Board requested that our staff evaluate and recommend what can and should be addressed first and put together an action plan. At this time the Board supports, in general, the recommendations of the transition plan.

## MOTION:

A motion was made by Ms. Fennelly to approve Recreation Accessibility Consultants' Final Report dated February 28, 2013 and work with staff to address the recommendations beginning with the higher use facilities, seconded by Ms. McAleer, all in favor and passed.

## Funding Request for Natural Resource Trust Fund:

Mr. Kean did inform the Board that he wants to look into how exactly the money would be used as it is not certain how the what the Legislature has planned.
