MOTION:

A motion was made by Ms. McAleer to approve the minutes from the October meeting as presented, seconded by Ms. Fennelly, all in favor and passed.

BUSINESS:

Approval of retirement of Hadley Heater, Park Crew Leader, Scott County Park on November 29, 2013:

Mr. Heater started with the Conservation Department in 1979 and the Board expressed their thanks to him for his 34 years of service. Mr. Heater will also be recognized by the Board of Supervisors at their December 3rd meeting.

MOTION:

A motion was made by Mr. Weis to approve the resignation of Hadley Heater with thanks from the Conservation Board for his many years of service, seconded by Ms. Fennelly, all in favor and passed.

Approval of Special Event Application from the QC Triathlon to use West Lake Park on 6/14/14:

This is the 15th year this race has been held at West Lake and is well coordinated and organized. Staff recommends approval with the provision that alternate plans need to be reviewed for spectators walking on the roads leading into the park and also being used by the race participants.

A motion was made by Mr. O'Donnell to approve the Special Event Application to use West Lake Park for the QC Triathlon on 6/14/14 charging \$1,200 for the use of the park, seconded by Ms. Fennelly, all in favor and passed.

The Board was also given a copy of a disconnect notice that was sent to the owner/mortgage holder of Lake Canyada and we are awaiting a response from them to determine how to proceed with completing a disconnect Agreement to remove Lake Canyada from our sewer system.

Glynns Creek golf course closed for the season on November 22nd. We are looking forward to a temperate spring and keeping rounds up.
