The meeting was called to order at 3:00 p.m.

MINUTES: The minutes of the February 11, 2015 meeting were reviewed for additions and/or corrections.

MOTION:

A motion was made by Mr. Mohr to approve the minutes from the February meeting as presented, seconded by Ms. Fennelly, all in favor and passed.

FINANCIAL REPORT: Reviewed and discussed for the month of February.

MOTION:

A motion was made by Ms. Fennelly to approve the bills from February as presented, seconded by Mr. Mohr, all in favor and passed.

BUSINESS:

Approval of Amending Park Rules & Regulations Removing Paddle Boards as a Prohibited Watercraft:

Mr. Kean explained to the Board that paddle boards had been prohibited from all lakes under the jurisdiction of the Scott County Conservation Board for safety and liability reasons and because they were not a Coast Guard approved vessel. However, they have now been designated as a Coast Guard approved vessel and the DNR began allowing them last year. Due to these changes staff is requesting approval to amend the Park Rules & Regulations removing paddle boards as a prohibited watercraft in Section 21 Fishing and Boating.

MOTION:

A motion was made by Mr. Mohr to approve amending the Park Rules & Regulations by removing Paddle Boards as a prohibited watercraft, seconded by Ms. Fennelly, all in favor and passed.

Approval of Request from Glynns Creek Golf Course to Offer a Spring Green Fee Special:

This is an annual request from the golf course and staff recommends approval.
