# Approval of Lake Restoration Professional Services Agreement with FYRA Engineering:

Based on the final results of the scoring criteria used by the review committee for Phase I of the RFP associated with the restoration of the lakes at West Lake Park, staff requested approval to enter into a Professional Services Agreement with FYRA Engineering. The agreement describes the four main project tasks, timelines and their proposed fees for Phase I (time and materials not to exceed \$39,426). Phase II and Phase III services and schedules will be negotiated at or near the completion of the preceding phase of work.

Approval of Lake Restoration Cooperative Funding Agreement with the DNR:

The Board was presented a Cooperative Funding Agreement with the Iowa DNR for Lake Restoration at West Lake Park. The agreement sets the terms required for the DNR to reimburse the SCCB 75% of the costs of Phase I of the RFP associated with the restoration of the lakes at West Lake Park. It sets the DNR's maximum contribution for Phase I at \$32,526.45, and the SCCB amount at \$10,842.15.
