## Approval of FY20 Capital Projects:

The Capital Projects for Fiscal Year 2020 were reviewed and discussed. The overall capital project costs for FY20 is \$3,315,000, with \$922,000 being funded by the County and \$1,762,500 to be paid by the DNR for the Lake Restoration project at West Lake Park. The remaining \$630,500 is to be expended from the County General and Conservation Capital Reserve Funds.

## **MOTION:**

A motion was made by Mr. Grenier to approve the FY20 Capital Projects, seconded by Ms. Fennelly, all in favor and passed.

## Approval of FY20 Vehicle & Equipment Expenditures:

The Vehicle & Equipment Expenditures for Fiscal Year 2020 were reviewed and discussed. The overall vehicle and equipment costs for FY20 is \$435,000, with \$237,800 being funded by the County. The remaining \$197,200 is to be funded by the Conservation Equipment Reserve and Golf Funds.

## **MOTION:**

A motion was made by Mr. Mohr to approve the FY20 Vehicle & Equipment Expenditures, seconded by Ms. Fennelly, all in favor and passed.

## Land Transfer Discussion:

The Conservation Board discussed briefly the possibility of transferring two parcels of land to the City of Princeton and associated requirements.

## MOTION:

A motion was made by Mr. Grenier to proceed with the transfer process and public hearing requirements for two land parcels to the City of Princeton, seconded by Mr. Mohr, all in favor and passed.

## Golf Report:

The Board reviewed and discussed the golf reports.

A motion was made by Mr. Grenier to approve the Golf Reports as presented, seconded by Ms. Fennelly, all in favor and passed.
