# Approval of Scott County Library request for free child swim passes for children who complete the library's summer reading challenge:

This is an annual request from the Scott County Library requesting that we partner with them for their 2022 Summer Reading Program "Read Beyond the Beaten Path", by providing a free single day pass to the pool or beach for each student completing their reading goal.

### **MOTION:**

A motion was made by Mr. Mohr to approve the Scott County Library's request to provide a free single day swim pass coupon to each student completing their summer reading goal and they are happy to help promote reading, seconded by Mr. O'Donnell, all in favor and passed.

# Approval of Request by Piranhas Swim Club to use Scott County Park Pool for the summer of 2022 swim practices

This is a yearly request from the swim club and staff recommended approval. A fee of \$175 for each practice session will be charged and billed to the swim club at the end of the season.

### **MOTION:**

A motion was made by Ms. McAleer to approve the Request from the Piranhas to use the Scott County Park pool as stated in the Permit Form along with charging a \$175 fee for each practice session, seconded by Mr. O'Donnell, all in favor and passed.

## West Lake Park Beach / Boathouse Opening Discussion

Mr. Kean addressed the Board regarding the 2022 Beach / Boathouse season at West Lake Park. The lake restoration project is now complete but recent rainfall has only filled roughly a third of Lake of the Hills. In addition to these conditions, he expressed concerns over recruiting enough lifeguards to staff the beach, which is more difficult than hiring mid-season Boat Rental Concession staff.

A motion was made by Mr. Mohr to grant Mr. Kean the leverage and authority to make decisions regarding the opening and offerings for the 2022 Beach /

Boathouse season, seconded by Ms. McAleer, all in favor and passed.

# Approval to Purchase two (2) John Deere FC15R Flex Wing Rotary Cutters for the Parks:

Staff requested approval to purchase two (2) John Deere FC15R Flex Wing Rotary Cutters for the parks as part of the routine replacement schedule. Staff recommended purchasing from Sinclair Tractor for a total price of \$48,000 based on the below bid results.
