Approval of FY24 Capital Projects:

The Capital Projects for Fiscal Year 2024 were reviewed and discussed. The overall capital project costs for FY24 is \$3,040,000, which will be funded as follows:

- \$1,000,000 Annual Appropriation
- \$1,600,000 ARPA Funds for the Water & Trail Projects
- \$440,000 CIP Reserve

Approval of FY23 Vehicle & Equipment Expenditures:

- \$300,000 Annual Appropriation
- \$26,000 CIP Equipment Reserve
