- 1) <u>EMA Proposed Staffing Changes:</u> Discussion of proposed staffing changes for the Scott County Emergency Management Agency (see attached memorandum).
- 2) <u>Discussion of Commission meeting times</u>: Results of a poll regarding meeting days and times for the quarterly Commission meetings.

E - Coordinator's Report

- 1) Training Update:
 - a. <u>ICS Logistics Section Chief:</u> Scheduled for May1-5, 2017. This course will provide the basis to managing the process of obtaining, deploying, tracking and demobilizing resources during a large scale event. We are hosting here at Scott County.
 - b. <u>ICS Incident Commander:</u> Tentatively approved, not scheduled. This course will provide the basis for managing an entire large incident or event.
 - c. <u>Community Emergency Response Team (CERT) training</u>: This training was held in February and March. We graduated 14 persons during this session and will likely repeat in the fall. Many thanks go to Medic EMS, Davenport Fire Department, RSVP and MidAmerican Energy for providing instructors, volunteers and supplies or equipment.
- 2) <u>Exercise/Event Update:</u>
 - a. <u>Area Maritime Security Committee 2017.</u> The QC AMSC is in the final stages of preparing for their 2017 full scale exercise on May 10, 2017. This will be a multi-site, multi-jurisdiction exercise that will allow us to explore the implications of closing the river and raising the Coast Guard security level. The scenario includes active shooters at multiple sites and a hazardous material release into the river. It coincides with the annual full-scale exercise on Rock Island Arsenal also. We will host a Unified Command Center and Joint Information Center here at EMA. We expect over 150 local participants in addition to the robust activity on the Arsenal.
 - b. <u>BIX 2917</u>: Planning for the BIX response begins in May. EMA participates in support of this event and does a partial activation of the EOC for the race.
- 3) Planning Update:
 - <u>Comprehensive Emergency Operations Plan</u>: We have begun our 2017 update process and will schedule approval at the July Commission Meeting.

- b. <u>Radiological Emergency Plan</u>: We are working with the State of Iowa and our partners to update our reception center plan. We are evaluating the possibility of a different site and will be implementing different monitoring equipment during the coming year.
- c. <u>Mass Fatality Plan</u>: The Scott County Medical Examiner is reviewing a first draft of our updated Mass Fatality Plan. Once they have done an initial review we will bring together our full planning team to review and finalize the plan. We are working with the Health Department, the Medical Examiner's Office, local funeral directors, our Rock Island County counterparts and state agencies to put together a plan that is actionable and integrates with state resources and plans. Once completed, we will schedule a series of exercises to test the plan.
- 4) <u>Technology and Equipment Update</u>:
 - a. <u>Mobile Command technology</u>: Most new components have been purchased and installed. Operators have been trained on the new equipment. Still outstanding is:
 - i. Replacing the back-up camera system
 - ii. Strategy regarding networking/telephones
 - iii. New printer is purchased, but needs to be installed
 - b. <u>Salamander System</u>: Rock Island County has purchased Salamander which will make our use consistent. The Scott County Healthcare Coalition intends to purchase an additional, large badge printer. Our vendor is holding an additional training in May.

Our vendor badged all 300+ attendees at the recent QC Disaster Readiness Conference. Our volunteers checked attendees in to the morning sessions and for lunch to demonstrate the system. The demonstration was very successful.

We continue to work with RSVP to train volunteers on the use of the system and hardware. Our vendor will be providing on-site training on May 24, 2017. We are also planning to begin badging and credentialing our EOC team and staff from response and other municipal organizations that would likely respond to work at either an incident command post or our EOC. Our longer term goal remains to get all Scott County first responders and disaster agency personnel credentialed into the system.

NOTICE OF PUBLIC HEARING -- AMENDMENT OF CURRENT BUDGET

The Emergency Management Commission of Scott County, Iowa will meet at: 1100 E. 46th St., Davenport, IA 52807, on April 20, 2017 at 6:00 p.m., for the purpose of amending the current Scott County Emergency Management Agency budget for the fiscal year ending June 30, 2017, by increasing expenditures in the following funds:

Emergency Management Fund (480) from \$296,086.00 to \$301,086.00

SECC/EMA Fund (489) from \$8,081,701.00 to \$8,092,200.00

Reasons for increases: to adjust Fund 480 expenditures for additional technology expenditures and to adjust fund 489 for additional operating expenditures not including in adopted budget.

The increase in expenditures set out above will be met from cash balances not budgeted or considered in the current budget.

There will be no increase in taxes to be paid in the fiscal year ending June 30, 2016. Any residents or taxpayers will be heard for or against the proposed amendment at the time and place specified above. A detailed statement of: additional receipts (other than taxes), cash balances on hand at the close of the preceding fiscal year, and proposed disbursements, both past and anticipated, will be available at the hearing.

- Subj: Proposed Staffing Change

As previously reported, the number of hours that our part-time Emergency Planner position is able to work each week has declined markedly from the authorized 25 hours per week. This is due to the primary work commitments of our incumbent, Nick Border. Further, I very much want to be flexible with Nick, to allow us to retain the expertise, credibility and experience Nick brings to our organization.

However, we are unable to meet commitments and complete the work of our Emergency Management Agency program with the fewer hours worked at that part time position. In the long term, I would like to discuss the programmatic priorities and goals of the Commission in order to best determine resources required for future fiscal years. That discussion however, will require additional information that I am not prepared to present at this point.

In the meantime, I propose and interim solution to increase the number of man-hours available to better meet our current workload with minimal budget impact. I propose that the Commission authorize the reduction of the authorized hours for the current part-time Emergency Planner position from 25 to 8 (from 1300 to 416). Further I propose creating an additional position authorized for a maximum of 30 hours per week, preferable 20 hours per week. The range of hours in the proposal results from a suggestion from a Commission officer to be flexible in order to attract the most qualified candidates.

I will discuss my proposal further and ask the Commission to consider my proposal at the April 20, 2017 EMA Commission meeting.
