NOTICE OF PUBLIC HEARING -- AMENDMENT OF CURRENT BUDGET

The Emergency Management Commission of Scott County, Iowa will meet at: 1100 E. 46th St., Davenport, IA 52807, on February 19, 2018 at 6:00 p.m., for the purpose of amending the current Scott County Emergency Management Agency budget for the fiscal year ending June 30, 2018, by revising expenditures in the following funds:

Increasing Emergency Management Fund (480) expenditures from \$249,770.00 to \$266,204.00

Reasons for increases/decreases: to adjust Fund 480 expenditures for staffing changes and additional professional service expenses; to adjust fund 489 for reduced capital expenditures included in adopted budget.

The increase in expenditures set out above will be met from increased receipts and/or cash balances not budgeted or considered in the current budget.

There will be no increase in taxes to be paid in the fiscal year ending June 30, 2018. Any residents or taxpayers will be heard for or against the proposed amendment at the time and place specified above. A detailed statement of: additional receipts (other than taxes), cash balances on hand at the close of the preceding fiscal year, and proposed disbursements, both past and anticipated, will be available at the hearing.

RECORD OF HEARING AND DETERMINATION ON THE AMENDMENT TO BUDGET

The Emergency Management Commission of Scott County, Iowa lawfully met on April 19, 2018, at 6:00p.m. at the place and time set in the public notice for the purpose of amending the current Scott County Emergency Management Agency budget for the fiscal year ending June 30, 2018. The Commission reviewed the affidavit of publication and then directed it be placed on file with the County Auditor. Upon taking up the proposed amendment, it was considered and residents and taxpayers were heard for or against the amendment.

Thereafter, and after hearing all residents and all taxpayers to be heard, the Board took up the amendment to the budget for final consideration and determined that said budgeted expenditures be amended as follows:

Emergency Management Fund (480)

from \$249,770.00 to \$266,204.00
