Scott County Emergency Management Agency Commission October 15, 2020 Meeting Minutes

The Scott County Emergency Management Commission met for their October 2020 meeting on Thursday, October 15, 2020, at 6:00 pm. This meeting was facilitated via teleconference only.

Others Present:

Dave Donovan, Scott County EMA; Brian Payne, Scott County EMA; Jim Hawkes, Scott County EMA and one unidentified attendee via teleconference.

Chair Gallagher called the meeting to order at 6:05 p.m. All Commission members appeared via teleconference.

Approval of Meeting Agenda and Minutes

Subj: Approval of nitrile glove purchase from Flex Pac, Inc

As Brian Payne outlined in the e-mailed communications on November 6, 2020, we became aware of an opportunity to purchase nitrile gloves late last week. A local vendor had availability for medical grade nitrile gloves in large quantities at a reasonable price. While we would prefer 5-mil thickness gloves for first responders, the product available is 4-mil thickness, a reasonable compromise, and better than standard 3-mil medical gloves.

During the pandemic response, the availability of nitrile gloves has been difficult, at best. We have found it difficult to nearly impossible to secure any significant supplies. When we do find gloves, we see prices that are double the price quoted for this opportunity.

As Brian outlined in his e-mails, we have issued a purchase order with Flex Pac, Inc., with offices in Rock Island. The purchase order is in the amount of \$40,302.90 for a total of 253 cases, or 2530 boxes (100 gloves per box), of various sizes at \$15.93 per box. We expect this purchase along with a previous purchase of large gloves, will allow us to have a nine or ten month supply on hand, with current usage conditions. However, with cases growing ever rapidly, and with a potential need for future vaccine distribution efforts, this amount may only supply us for six months, or even less. We expect that supplies will normalize at some point, but are told to expect the shortage to last well into 2021.

This purchase is funded from two sources, again per Brian's e-mail. The first source is from our EMPG-Supplemental grant, in the amount of \$22,832.04. We plan to fund the remaining \$17,470.86 from our agency fund balance. We have the option to apply for reimbursement for this amount under Public Assistance from the Federal Emergency Management Agency as part of the COVID-19 response. That funding source is certainly not guaranteed to reimburse us. However, we feel that risk is worth taking. With the current tight supply and limited availability of gloves, we would rather spend the dollars from fund balance with no reimbursement, than risk

running out of this critical personal protective equipment before the pandemic eases and supplies return to normal.

We recommend that the Scott County Emergency Management Commission formally approve the purchase of 253 cases of nitrile gloves from Flex Pac, Inc., in the total amount of \$40,302.90.

We will have this on the next EMA Commission agenda for discussion and approval.
