Scott County Emergency Management Agency Commission June 22, 2023, Meeting Minutes for Approval

The Scott County Emergency Management Commission met for a meeting on Thursday, June 22, 2023, at 6:00 p.m. The meeting was conducted in-person at Scott Emergency Communication Center in the Emergency Operations Center conference room.

Mayor Gallagher called the meeting to order at 6:00 p.m.
