Meeting Minutes

September 26, 2014 at 9:30 a.m.

The Scott County Local Emergency Planning Committee (LEPC) met on September 26, 2014 at 9:30 a.m. in the Scott County Emergency Management EOC conference room, 1100 46th St., Davenport, IA 52807.

Decker Ploehn called the meeting to order at 9:30 a.m. Introductions were made around the table of those present.

Ross Bergen made a presentation regarding revised federal regulations regarding hazardous materials and the transport of crude oil through the area.

Bergen discussed the HazMat symposium, scheduled for October 23-24, 2014 at the Fire Service Training Bureau in Ames, IA. He advised that this is a good training opportunity, especially for fire and hazmat first responders.

Discussion continued regarding the enhanced risk of the Bakken crude oil that is currently being shipped via rail through the area. Discussion ensued regarding routing of the crude oil shipments. Denny Coon to arrange for industry representative to speak to the Scott County LEPC at one of the next meetings in 2015. Further discussion ensued surrounding having the industry representative speak instead at Quad City Emergency Planning Committee rather than LEPC since it seems there is a bigger risk in Illinois than Iowa in the local area.

Bergen discussed ESF-10 annual update and the need for LEPC to review the plan each year. Ross indicated that there were not any major changes. He asked LEPC members to review and get any comments or recommended changes to him prior to March 31, 2015. He will consolidate any recommended changes or updates, distribute final copies and submit to the state.

Ploehn opened the floor for other discussion.
