Minutes of the December 4 Meeting

Homeland Security/EMA/IMT Report

Discussion: Ross Bergen, Jerry Shirk, Jeremiah Cowgill

Ross reported the budget is completed. The Commission will have their budget meeting on Tuesday, February 9th. He has been conducting Radiological Emergency Response Awareness Training and has been reviewing and updating the County Multi-Hazard Plan Act. The Annex is working on hazard analysis.

The National Weather Service, Homeland Security and Safeguard Iowa Partnership will host a webcast of the 2010 Flood Predictions at 10 a.m. on February 22nd. Ross will forward the link to view the webcast for anyone that is interested.

Jerry reported on March 2nd they are hosting an Emergency Planning Class. It is geared around Illinois administrative rules. The ice jam flood on the Rock River over the past month has brought all the jurisdictions together. An incident action plan was developed.

Jeremiah reported the Quad Cities Area Maritime Security Committee oversight through the Coast Guard Port Security St. Louis POC Jared Angelle Port Security Specialist is looking for a QCAMSC Chair Person. They are looking for voting members for the Executive Committee along the river as well. The next meeting will be March 30th at the Core of Engineers building. There are 100% Port Security Grant funding opportunities. The application deadline is February 12th.

Operation Fat Tire

Ross reported on Tuesday, February 2^{nd} at 9 a.m. a functional exercise for Operation Fat Tire will take place at the Scott County EOC. It will involve the EMA, Health Department, County Administration, PIO, Genesis and Sheriff's Office. It is based on a Ragbrai scenario where a large crowd of people are together and an unforeseen event occurs. An after action report will be completed after the exercise.
