Call to Order-Introductions

Everyone introduced themselves.

Minutes of the April 29 Meeting

Motion to approve the April 29th meeting minutes was seconded and approved unanimously.

Homeland Security/EMA/IMT Update

Discussion: Jerry Shirk, Ross Bergen

Jerry reported that Port Security Grant applications are available. He stated that anyone applying for the grant should be aware of the various due dates of the forms. Ross announced that there will be a QC PIO meeting at SECC on June 16th to familiarize the group with the new JIC and EOC. He explained that an MOU has been finalized with United Way to share registered/self-identified special population information via their 2-1-1 system. Lastly, Ross shared the list of emergency trailer supplies so that the group would know what type of sheltering equipment the county had available to them upon request.

SECC Update

Pam reported that they are operating and functional.

Hospital/Healthcare Update

Discussion: Dave Kelly, Trent Mull

Dave explained that they have been meeting with fire and MEDIC to prep for the upcoming BIX and RAGBRAI races in July. He also stated that they continue to hold several internal drills. Trent announced an upcoming full-scale evacuation drill on June 20th.

Public Health Report

Discussion: Nita Ludwig, Bethaney Conklin, Amy Cannady, Denny Coon,

Nita reported she attended the Integrated Public Health and Medical Training Summit with Bethaney. They held an IS-100 and IS-700 Class and just completed their Local Technical Assistance Review with the State of Illinois. They will be holding two Pandemic Tabletop Exercises. One will be with their Health Department Staff and the other with the MRC Volunteers and other community partners that participated in their Focus Groups held in April. Lastly, they did a Hospital Request Drill for S & S Supplies with Trinity, Illini and the EMA all participating.

Bethaney reported there is a lot of planning occurring for the next fiscal year. She added that the Regional Alliance Committee continues to look at priority funding.

Amy reported on the measles case in Dallas County, IA, and the proactive steps the Health Department has taken to notify Scott County physicians, media, and general public about the seriousness of the disease. Denny provided an update on PHER spending.

EMS Report

Brian reported SCEMSA was awarded a grant for equipment upgrades for \$77,507 from the Regional Authority Spring Riverboat Grant. Beginning June 1st the association will have one year to purchase the equipment designated in the application. Group purchasing and bid processes will be used to “stretch” the grant dollars. The next meeting is scheduled for June 16th at the Scott County Health Department.

Fire Service Report

Bart and Scott reported they discussed communication challenges departments are having in the Northern and Western tier of the county communicating with Cedar, Clinton and Muscatine Counties. Scott added their next meeting will be July 28th at the SECC.
