Call to Order-Introductions

Minutes of the May 27 Meeting

Scott County LEPC Bylaws

Discussion: Ross Bergen

Ross explained that in order for the QCEPC to be recognized by the state as a Local Emergency Planning Committee (LEPC), that bylaws had to be in place. He stated that he is currently working on those, and will share those with the group in the near future.

Homeland Security/EMA/IMT Report

Discussion: , Ross Bergen, Jerry Shirk, Bart Howard

Ross shared that there is a link on the EMA website for immediate weather information on watches and warnings. He explained that BIX/RAGBRAI planning meetings continue to take place, as the race dates get closer. He is currently working on updating a map of siren locations. The Area Maritime Security committee meeting was held on June 3rd to focus on finalization of the grant requests. Jerry reminded the group that the airport is having a Disaster Drill on August 9th. Bart gave the group a synopsis of the flooding issues in the Council Bluff area from an IMT perspective.

SECC Report

Brian reported they have hired 3 new dispatchers which are in the training process. They are working with New World Systems on CAD/RMS issues and are in the process of developing a Recording Policy for the SECC. Pam has been coordinating for the communication aspect of the various events going on.

Denny reported for Genesis that they have been busy attending and hosting BIX/RAGBRAI planning meetings.

Public Health Report

Bethaney reported the Public Health Emergency Preparedness Program is getting ready to start a new 5 year project period with the new grant cycle beginning August 10th with new activities and a lot of changes. She announced the various cuts from the PHEP program side. Denny provided an update on PHER spending in regards to the wireless project for the Administrative Center. He also explained the new grant structure for FY'11-'12, as well as the status of United Way's 2-1-1 service. Denny announced that another meeting regarding the future of VOAD and United Way's 2-1-1 service will meet directly following the QCEPC meeting.

EMS Report

Brian shared they met on June 16th. The group worked on grant plans, 2011 protocols and was updated on the LUCAS mechanical CPR devices. Chuck reported they are in the process of creating a non-agency specific position so that all agencies can put their low frequency high critical call data together in an effort to analyze how the area system is doing as a county and look for areas needing improvement. Brian added they have a light duty paramedic that will be editing and producing the new Scott County Protocol.
