Call to Order-Introductions

Everyone introduced themselves.

Minutes of the 6-24 Meeting

Motion to approve the June 24th meeting minutes was seconded and approved unanimously.

Homeland Security/EMA/IMT Report

Discussion: Ross Bergen, Jerry Shirk

Ross hosted the 14 county Region 6 Board Meeting on August 9th and Board of Health Meeting on August 18th at the EOC. On September 1st the Bettendorf Citizens Academy Alumni will tour the facility, September 19th the public hearing for review of the draft of the Scott County Hazard Mitigation Plan will be held at the Scott County Library in Eldridge, September 22nd Exelon will have their Annual Meeting and October 13th and 14th there will be a Hazardous Materials Emporium in Ames.

Jerry reported the Area Maritime Security grants have been awarded. The airport disaster drill went well on August 9th and the AAR has been sent out. Lastly, the tornado that hit the Joplin, Missouri hospital AAR is out. Jerry said the common theme is that plans are important but it is crucial to exercise.

Hospital/Healthcare Report

Discussion: Dave Kelly, Trent Mull, Dr. Frank Claudy

Dave reported that the report and orientation regarding the Chempak stored at their facility that was postponed last Spring will be scheduled for this Fall.

Trent reported that the Quad City Marathon will be held September 25th.

Dr. Claudy reported that the Illini Campus tested the Command Center during a disaster drill on August 9th in conjunction with the Quad City International Airport in Moline disaster drill.

Public Health Report

Discussion: Bethaney Conklin, Denny Coon

Bethaney explained the different capabilities from which each county must choose three to document and exercise this next fiscal year. The Region voted to choose the same three to work on together, and share some of the burden of proof. The capabilities chosen were Emergency Operations Coordination, Emergency Public Information and Warning, and Information Sharing. Bethaney also announced that each county will be responsible to hold one workshop and one tabletop exercise, tied to the capabilities chosen.

Nita reported that Rock Island county has submitted their grant application. One of the main deliverables they are going to focus on is the Community Assessment and Vulnerability study. They have a full-scale exercise scheduled for June. The state of Illinois purchased a Comprehensive Emergency Management program that they have given to all the counties. Lastly, they participated in the Quad City International Airport in Moline disaster drill.

Denny shared that Senior Voice is the main sponsor of an event at the Knights of Columbus as a 9-1-1 tribute to all First Responders on September 15th. Denny and Amy are working with Gloria Fisher to organize invitations. With remaining grant funds new 800mhz radios were purchased and are in the process of being programmed.

EMS Report

Discussion: Denny Coon, Linda Frederiksen

Linda reported that Dr. Frank Claudy, Chairman of the MEDIC Board will be retiring from the Board in September. He has served on the MEDIC Board since 1998. Linda thanked him for his support and services.

Fire Service Report

Law Enforcement/Intel/TSA Report

Discussion: Kevin Johnson, Sheriff Conard

Kevin reported the Full Body Imaging Scanners will be deployed at Moline, Peoria and Bloomington in October/November.

Sheriff Conard explained that a yellow dot placed on the rear window of a vehicle tells first responders to look in the glove compartment for a corresponding yellow folder that should have information about the special medical needs the individual may have. They have handed out approximately 200 dots.
