Homeland Security/EMA/IMT Report

Discussion:

Ross Bergen shared that the North Scott School insurance carrier is holding a disaster tabletop exercise on October 18th. October 24th is the Radiological Emergency Response Plan Dress Rehearsal. The actual FEMA evaluated exercise will be held December 5th. October 26th grant applications are due for the FEMA Community Resilience Innovation Challenge. A limited number of grants up to \$35,000 will be awarded. There will be a LEPC meeting directly after the QCEPC Meeting October 26th.

Jerry Shirk reported the Rock Island Arsenal Exercise went well and the After Action report will be sent to all the participants. Augustana College was approached and accepted to hold an Active Shooter Drill.

SECC Report

Brian Hitchcock reported the Backup Center construction is completed as well as the storage facility. They are presently working on the installation of the phone, radio, recording system and Positron 911 equipment at the Backup Center.
