Homeland Security/EMA/IMT Report

Discussion:

Ross Bergen reported October 24th a pre-exercise for the FEMA evaluated Radiological Response Exercise on December 5th was held. He reported North Scott School had good participation on their Active Shooter Tabletop exercise held October 18th. Jerry Shirk reported for Jeremiah Cowgill that the Rock Island Arsenal Exercise After Action report will be sent to all the participants. Jeff Yerkey reported Mercer County EMA did a full scale mass causality exercise involving a tornado on September 27th. Mercer County EMA is holding an After Action Conference October 30th at 3:30 pm at the Mercer County Health Department.
