BIX Planning

Discussion:

Bart Howard reported BIX planning is going well. There will be additional law enforcement over previous years. The weather forecast is ideal. Dave Kelly added that the community effort has been great at planning meetings to help ensure the BIX is safe and successful.

Homeland Security/EMA/IMT Report

Discussion:

Nita Ludwig reported that the Citizen Core group is planning a workshop September 11th.

Denny Coon shared discussion was held at the Fire Chief's Meeting on updating the Resource List and creating a procedure on accessing the equipment.

SECC Report

Discussion:

Dave Donovan reported the recruitment for the SECC Director position is underway. Applications are due July 29th. The selection process is planned for late August/early September with an intent the new Director would be in position the end of September/mid-October.

Internally cross-training is being done on the dispatch floor and staff is working on the Emergency Operations Plan for the Center.

Community Resilience/VOAD Report

Discussion:

Denny shared at the last VOAD meeting there was a representative from Safeguard Iowa Partnership and the Quad City Chamber of Commerce in attendance. It was a productive meeting opening lines of communication.

Hospital/Healthcare Report

Discussion:

Chris Webster shared the remodel project at the Illini Campus will begin soon. Any ambulance traffic or logistic changes will be communicated. Chris also reported there is a very potent version of heroin in the Chicago area. It is proving itself to need very high doses of Narcan and in some cases Narcan doesn't work. Chris added any cases that come up he would appreciate knowing so they can report it to the Health Department in Chicago.

Dave Kelly reported they have been working on BIX preparation plans.

Trent Mull shared they have been working with Genesis on BIX planning. The John Deere Golf Classic went well. The weather was ideal resulting in half the patient population over previous years.

Public Health Planning Report

Discussion:

Nita reported Rock Island County is in the process of converting over to electronic health records. They are anticipating going live August 15th and 16th. An Augustana College intern worked with them over the summer trying to increase their Medical Core Reserve volunteers. Lastly, two TDAP clinics were held at Rock Island High School.

Denny reported that although the new grant year began July 1st they are currently working under a three month extension. Progress on the RFP for the coalition is being made.

EMS Report/EMS Study
