Call to Order-Introductions

Discussion:

Minutes of the May 30 Meeting

Discussion:

SECC Report

Discussion:

Denise Pavlik stated that she is working with Bart Howard from Davenport Fire on the Active Shooter exercise at St. Ambrose on July 1, 2014.

Homeland Security/EMA/IMT Report

Discussion:

Jerry Shirk announced that Exelon will hold a pre-exercise on July 16th, to plan for the full-scale exercise on August 27th. He stated that a mass casualty exercise will be held at the QC International Airport on August 13th.

2014 Exercise Report

Discussion:

Bart Howard and Al Loeffelholz gave an update on BIX 7 preparations, stating that law enforcement and medical staff presence has been increased again this year. Bart explained that he is working with the Quad Cities Incident Management Team to complete a more thorough IAP for the event.

2015 QCERC Planning Initiative

Discussion:

Trent Mull explained that the Spring Disaster Readiness Conference went well and they are currently discussing plans to hold a conference next year. Denny added if anyone was aware of any speakers on man or nature made disasters to please let one of the planning group members know.

Community Resilience/VOAD Report

Discussion:

Nita Ludwig shared the VOAD group is moving forward. They continue to reach out to faith based leaders for their input and support.

Kelly Thompson with the Community Foundation of the Great River Bend explained they have a renewed initiative to work with local agencies in regards to disaster planning and recovery efforts.

Hospital/Healthcare Planning Report

Discussion:

Trent Mull announced an IMT class on July 9th, as well as preparations for the John Deere Classic July 7th thru 13th. He requested medical volunteers for the tent contact him directly.

Public Health Planning Report

Discussion:

Nita Ludwig explained that ACA counselors will be kept on staff till August. She also stated that a tabletop exercise for Anthrax with the postal service will be held on July 2nd. Lastly, Nita announced that all department PIOs will be attending social media training in Bloomington, IL, and PHP staff will attend their annual summit in July in Schaumburg, IL.

Bethaney Conklin shared that she continues to work on end-of-year reports for PHP, and that the capability completed this year involves EPI and Surveillance. She explained that next year they will focus on EOC Operations, Medical Surge, and Non-Pharmaceutical Interventions.

Denny Coon reported that Scott County PHP has also completed year-end reports, and that the Healthcare Coalition is currently working to hold future trainings on cyber security and continuity of operations plans for elected officials. The trainings are in response to feedback from the Quad Cities Disaster Readiness Conference.

Amy Cannady added there will be an advanced EPI course on August 7th at the Scott County training center. Anyone interested in attending should contact her.
