Call to Order-Introductions

Discussion:

Minutes of the July 31st Meeting

Discussion:

Discussion:

Homeland Security/EMA/IMT Report

Discussion:

Jerry Shirk shared October 28th at the Rock Island County EMA the IEMA will be presenting a Debris Management Course. This course is aimed for federal, state and local emergency management officials who may be involved in debris management or those agencies who want to become familiar with debris management. Registration must be done thru the IEMA website. December 1st and 2nd at the Rock Island County EMA there will be a Homeland Security Exercise Evaluation Program Class. This recently revised two day course provides a basic overview of the HSEEP exercise process. This course is aimed for federal, state and local emergency management officials, volunteer and other agency officials involved in emergency management who are responsible for an exercise program, serve as a member of an exercise planning team and/or fulfill a role in one of the following areas of the exercise design process: design, development, conduct, evaluation or improvement process for an exercise. October 6th the Maritime Security Committee will meet at SECC to begin building a tabletop. Lastly, October 14th the Rock Island County LEPC meeting will be held at the EMA office with an IMT meeting following.

Scott Starns reported they have had their first planning meeting for their FY'16 full-scale exercise in May. The scenario will be a barge incident in the general vicinity of Lock and Dam 15.

Nick Border shared the Bi-Annual Radiological Training by Iowa Homeland Security and Exelon will be September 30th at the SECC.

Robbin Dunn shared there was a three day training at the Davenport Works Building on September 15th - 17th. The training focused on Emergency Operations Center (EOC) functions in a sustained operational period. Representatives from Davenport Public Works, Davenport Fire Department, Davenport Police Department, Scott County Emergency Management, and the SCHD participated. Texas A & M University Extension provided the training through a contract with FEMA. Denny Coon added many ideas from the training will be considered for implementation in the Scott County EOC.

Chance Kness shared December 7th& 8th and 9th&10th there will be an ALERRT Active Shooter Training by Texas Extension in Clinton. If interested contact, Chance.

QCDPC Conference 2016

Discussion:

Jerry Shirk shared the Committee will meet directly after the QCEPC meeting to begin planning the "Third Annual Quad City Disaster Preparedness Conference" scheduled for April 7, 2016.

Healthcare Coalition Update Discussion: Denny Coon shared this new grant year the Coalition will be reaching out to their Tier 2 and Tier 3 community partners. Other Hospital, Healthcare, PH Reports Discussion: Kate Meyer reminded the group that Dillon Magers, Manager HazMat Field Ops and Response with BNSF Railway will give a hour presentation at the October 30th QCEPC Meeting. His duties include: response to releases and other hazmat emergencies, hazardous materials emergency planning and preparedness, community outreach and training and DOT reporting and compliance. Kate also explained that they have been working with Augustana College. Augustana has a Community Health Outreach Organization (ACHOO). One of their requirements will be to join the Rock Island County Medical Reserve Core (MRC).
