Jerry Shirk reported the National Weather Service gave a presentation at their last IMT/LEPC Meeting. They participated in the Augustana College Active Shooter Tabletop. The Full-Scale Exercise is scheduled for April 26th. Lastly, Jerry shared Augustana College is sponsoring a Quad Cities Workplace Violence Preparedness Seminar on February 19th.

Dave Donovan reminded the group the Maritime Security Tabletop will be March 1st.
