Healthcare Coalition Update

Discussion:

Denny Coon reported March 30th they will be participating in a Tabletop in Des Moines for Mass Distribution on State and Federal Medical Assets in a Disaster with their Full-Scale Exercise scheduled on May 4th in Des Moines. On June 3rd a Tabletop Exercise for all Eastern Iowa Coalitions is scheduled at the Genesis Adler Center and on June 14th a Full Scale Exercise is scheduled at the Scott County Tremont Warehouse building. IDPH will bring in a semi load of supplies that will be unloaded and reloaded with a pallet of supplies to be unpacked and rearranged for redistribution. On June 16th a Mass Distribution Exercise will be held at the Fairgrounds concurrent with a similar exercise being done by the Rock Island County Health Department.

Trent Mull shared the Coalition is currently working with Nick Border on the Fatality Management Plan and Checklist for Capability 5. In addition the Coalition participation in the State Asset Distribution Exercise coincides with Capability 9.
