Homeland Security/EMA/IMT Report

Discussion:

Jerry Shrik reminded the group of the Command and General Staff class administered by the Illinois Fire Services Institute. This is a week-long training beginning June 27th. On July 13th there will be a Rock Island County LEPC meeting. The Emergency Manager from JoDaviess County that was involved in the Bakken Oil spill and fire will be giving a presentation. July 19th there is a Maritime Planning Committee meeting scheduled at SECC. They will begin planning an exercise for 2017.

Dave Donovan reported July 26th there will be an Emergency Preparedness Workshop for Faith Communities. Registration is free with limited seats available. Lastly, Dave shared August 24th there will be a tabletop exercise with the State of Missouri requesting Iowa to accept 50,000 evacuees after a large earthquake strikes scenario.

Bethaney Conklin and Jerry explained TRANSCAER (Transportation Community Awareness and Emergency Response) is a voluntary national outreach effort that focuses on assisting communities to prepare for and to respond to a possible hazardous materials transportation incident. Jerry added TRANSCAER will have a representative at the Maritime Planning Committee meeting.

Combining Rock Island and Scott LEPCs

Dave Donovan and Jerry Shirk shared they have been exploring the possibility of combining the Rock Island and Scott County LEPC's. Once the details have been worked out it would go to a formal vote.

Exercise/Drills Update

They appreciate the help from the volunteer victim/patients. Pam Paulsen reported the hand radios were a useful tool and worked well between the two Health Departments.
