Homeland Secuirty/EMA/IMT Report

Discussion:

Dave Donovan reported the Quad City Area Maritime Security Committee continues to plan for the May 10^{th} Exercise. He shared the Civil Air patrol will be participating in the exercise as well. The Logistics Section Chief course will be offered May 1, 2017 thru May 5, 2017 at SECC. Dave shared that C.E.R.T. training has begun. He thanked Davenport Fire, Rock Island Fire and MEDIC EMS for providing assistance with the class.

Jerry Shirk shared there will be a 3M Active Shooter Tabletop on March 24, 2017. They will be receiving the Salamander System in April. The IMT meeting will be April 12, 2017 with a presentation on T-Cards.

Chief Jeffrey Yerkey reported the Mississippi River is projected to be at 15.6 ft by the end of the week March 3, 2017.
