Discussion:

Dave Donovan motioned to approve the April 28, 2017 meeting minutes and Richard Vermeer seconded, the motion passed.

Homeland Security/EMA/IMT Report

Discussion:

Dave Donovan reviewed the May 10 Full scale Maritime exercise for the group, specifically from the perspective of those working in the EOC. Civil Air Patrol participated for the first time and demonstrated their live video and photography capabilities; this new capability was highly valued and will be used as often as possible during exercises and real life events. Over 40 organizations were represented in Unified Command during the exercise. One potential area for improvement that was discussed involved the Joint Information Center; the PIOs were not able to put out quality products while also trying to adjust to the time jumps that were built into the scenario. Future scenarios may need to be designed without the addition of time jumps specific to the PIO group. Dave Mentioned the AAR is still in the production phase, but would be sent out to those that participated when it is completed.

Dave also discussed the Salamander printers and software that were recently purchased by both Scott County and Rock Island County EMA. Salamander would allow the counties to pre-credential responders before an emergency; this software could also be used as a time tracking and patient tracking resource on scene. Dave would like to create a committee that would be responsible for writing the policies that would be used during the roll out of salamander Quad City wide.

Jerry Mentioned that he would be applying for the Maritime grant (totaling \$25,000) fairly soon, they are considering buying drones for the PD in the area.
